- 4. Presentation of California Rural Water Association Source Water Protection Plan John Wendele: District Manager Willie Rodriguez introduced John Wendele from California Rural Water Association to the Board. John Wendele presented a power point to the Board about what and why having a Source Water Protection Plan is so important. He informed the Board that the final document of the Source Water Protection Plan and Vulnerability Document are not public documents because it can be seen as a roadmap for someone to contaminate the Burney Water District's water source.
- **Determine Board Member Appointment of Steering Committee for Source Water Protection Plan:** The Steering committee usually consist of the Manager, a Board Member, and a member of the community that is a stakeholder. John Wendele introduced Keith Greenwood from Sierra Pacific whom is the District Manager for the Timber lands that he invited to participate in being a member of the Steering Committee. Director Ryness moved to appoint Director Hamlin as a member of the Steering Committee for the Source Water Protection Plan. Director Rogers seconded the motion. Review and Edit Injury and Illness Prevention Plan: District Manager Willie Rodriguez summarized the Injury and Illness Prevention Plan and explained that it should be the basis for Burney Water District's safety program. He would like to limit exposure to employees and it is the regulatory requirement from Cal OSHA. Willie has some revisions he would like to make to it before he brings it to the Board to adopt the document, and would like to keep the procedures separate from the document so we will not have to revise the plan every time certain items change. This document helps inform supervisors of what they need to do and how they need to inform the workers under them and gives the employees the right to refuse to do a job if they fear it may hurt them. This also holds employees responsible for working safely.

- **Review Reserves Balance Sheet:** District Manager Willie Rodriguez summarized the Reserves Balance Sheet. He went over accounts that he would like to clear out and move the remaining balance into our Tri Counties Bank account. He would like to start moving money after depreciation is actually booked from our main cash account each month into the capital improvements fund for future capital improvement work to be done based on the depreciation of the infrastructure.
